<b>Personal Statement:</b> Statement signed by applicant specifying reason for settling in Portugal, intended area of residency and type of accommodations (rental, purchase of private property, or family home.)		
<b>Proof of accommodation:</b> Lease agreement signed or letter from inviting party or declaration from family member residing in Portugal along with "Term of responsibility".		
Copy of the <b>return flight ticket</b> .		

SPECIFIC DOCUMENTS	
Proof of family ties that justify the accompaniment.	
<ul> <li>For this purpose, family members mean:</li> <li>The spouse;</li> <li>Minors or disabled children dependent on the couple or one of the spouses;</li> <li>Minors adopted by the applicant (when single), by the applicant or by the spouse, as per decision of the competent authority of the country of origin, provided that the law of that country recognises adopted children with rights and duties identical to those of natural filiation and that decision is recognised in Portugal;</li> <li>Children of legal age, dependent on the couple or one of the spouses, who are single and studying at an educational establishment in Portugal;</li> </ul>	

<ul> <li>Children of legal age, dependent on the couple or one of the spouses, who are single and studying, whenever the holder of the right to family reunification has a residence permit issued under article 90.º-A;</li> <li>First-degree relatives in the ascending line of the resident or their spouse, provided they are dependent on them;</li> <li>Minor siblings, provided they are under the guardianship of the resident, in accordance with a decision issued by the competent authority of the country of origin and that decision is recognised by Portugal;</li> <li>The partner who, in Portugal or in other country, with whom the foreign resident citizen contracted a civil partnership, duly proven under the law;</li> <li>Single minors or disabled children, including adopted children of the partner of the civil partnership, provided they are legally under the protection of the partner.</li> </ul>	
<b>Proof of availability of stable and regular means</b> , sufficient for the needs of the residency visa applicant and the accompanying family members during the intended period of stay or for the period of 12 months, whichever is shorter, determined under the provisions of article $2^{\circ}(2)$ of Ordinance $n^{\circ}$ 1563/2007, of December $11^{\text{th}}$ .	
ADITIONAL DOCUMENTS FOR MINORS	
<ul> <li>Minors who are not traveling with both parents or are traveling with a third person:</li> <li>a travel authorization issued by the parent with whom the minor is not traveling or by both parents, with a legalised signature; or</li> <li>a court decision (when applicable) authorizing the minor to travel and stay in Portugal for the foreseen period according to the purpose of stay, with the Hague Apostille (if applicable) or legalised; and</li> </ul>	
Photocopy of the parent's national identity card.

<ul> <li>CPLP citizens are exempt from presenting: <ul> <li>Travel insurance;</li> <li>Return transport ticket; and</li> <li>Means of support, upon presentation of a sponsorship letter in the following terms:</li> </ul> </li> <li>a) Presentation of a sponsorship letter, with a legalised signature, issued by the host entity; or,</li> <li>b) Presentation of a sponsorship letter, with a legalised signature, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, which guarantees food and accommodation for the visa applicant, as well as the replacement of removal costs, in case of irregular stay.</li> </ul>		
Notes:		

- Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the "<u>Consulate General of Portugal</u>". VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application
- Failure to submit all the necessary documents may lead to the rejection of the visa application.
- The Consular Post reserves the right to request supplementary documents if necessary.
- Even if all the requested documents are presented, it does not imply the automatic granting of the visa. The visa fee is not refunded if the visa is refused.
