<b>Proof of accommodation:</b> Lease agreement signed or letter from inviting party or declaration from family member residing in Portugal along with "Term of responsibility".			
Copy of the <b>return flight ticket</b> .			
Proof of the existence of <b>means of support</b> , which can be provided through <b>presentation of a sponsorship letter</b> , with legalised signatures, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.			
In the case of patients traveling under Cooperation Agreements/Medical Boards, proof of means of support and accommodation may be replaced by a statement from the Embassy in Lisbon ensuring the referred conditions.

ADITIONAL DOCUMENTS FOR MINORS

<ul> <li>Notes:</li> <li>Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the "Consulate General of Portugal". VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application</li> <li>Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> </ul>			
<ul> <li>The Consular Post reserves the right to request supplementary documents if necessary.</li> <li>Even if all the requested documents are presented, it does not imply the automatic granting of the visa. The visa fee is not refunded if the visa is refused.</li> </ul>
