VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application • Failure to submit all the necessary documents may lead to the rejection of the visa application. • The Consular Post reserves the right to request supplementary documents if necessary. • Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
