CPLP citizens are exempted from presenting:  • travel insurance,  • means of subsistence, and □ return transport ticket  upon presentation of responsibility term in the following terms:  a) Presentation of a term signed by the host entity for interns or workers, as well as by the organization responsible for student exchange or volunteer programs, or,  Presentation of a term of responsibility, signed by a Portuguese citizen or a foreign citizen, with a residence permit in Portugal, which guarantees food and accommodation for the visa applicant, as well as the replacement of removal costs, in case of irregular stay.	
Proof of Address in USA: Copy of Lease agreement and/or copy of driver's license.	
Note: Failure to present all necessary documents may result in the visa application being refused. The Consular Post has the prerogative to request additional documents when it considers fit to do so The presentation of all necessary documents in the visa application may not be construed as an automatic approval of the visa.
