<b>CPLP citizens are exempt from presenting:</b> <ul style="list-style-type: none"> <li>Travel insurance,</li> <li>Return transport ticket; and,</li> <li>Means of support, <b>upon presentation of a sponsorship letter</b>, with a legalized signature, issued by a Portuguese or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as all the replacement of removal costs, in case of irregular stay.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<b>Notes:</b> <ul style="list-style-type: none"> <li>Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the “<b>Consulate General of Portugal</b>”. VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application.</li> <li>Failure to submit all the necessary documents may lead to the rejection of the visa application.</li> <li>The Consular Post reserves the right to request supplementary documents if necessary.</li> <li>Even if all the requested documents are submitted, it does not imply that a visa will automatically be granted.
