Proof of the existence of means of support , which can be provided through presentation of a sponsorship letter , with legalized signatures, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.			
In the case of patients traveling under Cooperation Agreements/Medical Boards, proof of means of support and accommodation may be replaced by a statement from the Embassy in Lisbon ensuring the referred conditions.

 CPLP citizens are exempt from presenting: Travel insurance. Return transport ticket; and Means of support, upon presentation of a sponsorship letter, with legalized signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay. 			

Notes:

- Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the "Consulate General of Portugal". VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application
- Failure to submit all the necessary documents may lead to the rejection of the visa application.
- The Consular Post reserves the right to request supplementary documents if necessary.
- Even if all the requested documents are presented, it does not imply the automatic granting of the visa. The visa fee is not refunded if the visa is refused.
