<p><b>CPLP citizens are exempt from presenting:</b></p> <ul style="list-style-type: none"> <li>Travel insurance.</li> <li>Return transport ticket; and</li> <li>Means of support, <b>upon presentation of a sponsorship letter</b>, with legalized signature, issued by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>

**Notes:**

- Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the "Consulate General of Portugal". VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application
- Failure to submit all the necessary documents may lead to the rejection of the visa application.
- The Consular Post reserves the right to request supplementary documents if necessary.
- Even if all the requested documents are presented, it does not imply the automatic granting of the visa. The visa fee is not refunded if the visa is refused.
