<p>Notes:</p> <ul style="list-style-type: none"> Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the "Consulate General of Portugal". VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application Failure to submit all the necessary documents may lead to the rejection of the visa application. The Consular Post reserves the right to request supplementary documents if necessary. Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
