| CPLP citizens are exempt from presenting: <ul style="list-style-type: none"> • Travel insurance, • Return transport ticket; and • Means of support upon presentation of a sponsorship letter in the following terms: <ol style="list-style-type: none"> a) Presentation of a sponsorship letter, with a legalized signature, issued by the host entity or, b) Presentation of a sponsorship letter, with a legalized signature, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay. | <input type="checkbox"/> | <input type="checkbox"/> |
| Notes: Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the “ Consulate General of Portugal ”. VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application <ul style="list-style-type: none"> • Failure to submit all the necessary documents may lead to the rejection of the visa application. • The Consular Post reserves the right to request supplementary documents if necessary. • Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
