<p>CPLP citizens are exempt from presenting:</p> <ul style="list-style-type: none"> Travel insurance. Return transport ticket. Means of support upon presentation of a sponsorship letter in the following terms: <ul style="list-style-type: none"> a) Presentation of a sponsorship letter, with a legalized signature, issued by the host entity or b) Presentation of a sponsorship letter, with a legalized signature, signed by a Portuguese citizen or a foreign citizen with a residence permit in Portugal, covering lodging and boarding, as well as the replacement of removal costs, in case of irregular stay. 	<input type="checkbox"/>	<input type="checkbox"/>
<p>Notes:</p> <ul style="list-style-type: none"> Applicants are required to pay the Visa Fee for National Visa D/E (all categories) by way of a money order or Banker / Cashier check in favor of the “Consulate General of Portugal”. VFS Service Fee can be paid via Debit/Credit card at the center while submitting the application. Failure to submit all the necessary documents may lead to the rejection of the visa application. The Consular Post reserves the right to request supplementary documents if necessary. Even if all the requested documents are presented, it does not imply the automatic granting of the visa.
