Letter of Guarantee signed and verified by the Administration Unit of Slovenia	Letter indicating the host's exact address of residence, the purpose of travel and stay ( <a href="https://www.gov.si/assets/ministrstva/MZEZ/Dokumenti/konzularne-zadeve/oddelek-za-vize/garantno_pismo.pdf">https://www.gov.si/assets/ministrstva/MZEZ/Dokumenti/konzularne-zadeve/oddelek-za-vize/garantno_pismo.pdf</a> )

<input type="checkbox"/>	An application without the complete set of documents according to the above-mentioned checklist may result in a rejection of my visa application.
