03	Original passport valid for no less than 30 calendar days after expiry of the intended stay	
04	Visa Fee Rs 5,300.00 ( <i>non-refundable</i> )	
05	A yellow fever vaccination certificate ( <i>where applicable</i> )	
06	A medical report on form BI-811 ( <i>original and not older than six months at time of application</i> )	
07	Police Clearance Certificate(s) in respect of applicant from each country where the applicant, after attaining the age of 18 years, has resided for 12 months or longer during the five years immediately preceding the date of application ( <i>original +copy and not older than six months at time of application</i> )	
08	Proof of kinship / relationship in a form of Birth Certificate ( <i>certified copy</i> )	
09	Certified copy of Marriage Certificate ( <i>English translation where applicable</i> )	
10	Written consent from both parents and full parental responsibilities and rights ( <i>where applicable</i> )	
11	Proof of a valid return or onward ticket or purchase of ticket	
12	Documentation outlining the purpose and duration of the visit, or a written invitation by the host(s) in the Republic, as the case may be	
13	In respect of a dependent child accompanying the applicant or joining the applicant in RSA: (a) proof of consent from one or both parents, in the form of a letter or affidavit (b) a letter from the person who is to receive the child in the Republic containing his or her residential address in the Republic where the child will be residing (c) a copy of the identity document or valid passport and visa or permanent residence permit of the person who is to receive the child in the Republic; and (d) the contact details of the parents or legal guardian.	
14	Certified copy of the host's ID and/or passport	
15	Proof of sufficient financial means (a) a three months bank statement ( <i>original signed and stamped</i> ) cash available to the applicant

17	Previous passports ( <i>10 years travel history where applicable</i> )	
18	A duly signed invitation from the host

20	Host's last three months bank statement ( <i>certified by the bank</i> )	
21	Proof of host's profession (study / employment / business / etc)	
22	Proof of host's monthly income	
23	Proof of host's residence in South Africa
