08	Certified copy of Marriage Certificate ( <i>English translation where applicable</i> )		
09	The financial assurance contemplated in section 18(1) of the Act shall be an amount, per person per month, as determined from time to time by the Minister by notice in the Gazette, to be proven by means of: (a) current salary advices or (b) a certified bank statement not older than three months at the time of application: Provided that the financial assurance shall not be required where the South African citizen or permanent resident is a dependent child.
