

SOUTH AFRICA LONG-TERM VISA APPLICATION CHECKLIST

The South African High Commission has provided guidance to help you submit your application. This guidance is available on the following website <https://visa.vfsglobal.com/uga/en/zaf>

This form will be used by the staff member who accepts your visa application to record the documents you have submitted with your application.

PLEASE NOTE:

1. **Applicants who have ever been rejected or overstayed should first appeal and get a waiver letter before submission.**
2. **Children below 18 years of age should attach a full birth certificate, court order for full custody, Parental Consent Affidavit signed and stamped by the Commissioner of oaths and consent letter if traveling alone or with one parent.**
3. **Children below 1 year of age do not require a yellow fever certificate.**
4. **Children below 18 years when visa is issued should travel with their original full birth certificate and Parental Consent Affidavit.**
5. **Children below 18 years require certified copy of the court order for guardianship in South Africa.**
6. **Please ensure that the passport is signed.**
7. **Applicants should submit in person.**
8. **For Group Applications Kindly Provide Copies of supporting Documents for each application.**
