1.	Duly completed & signed application form, in English or Swedish. 用英文或瑞典文填写完整并由申请人签字的申请表。			
2.	For Applicants who have been collected Biometrics for Schengen Visa in the past 59 months: & Applicants below 12 years old: One passport size photo. The photo must be: full face (facing the camera directly with your eyes looking straight at the camera); in colour with a light background; no more than six months old and resemble you; you must be bareheaded, unless you have special religious reasons. 在过去 59 个月内已采集过申根指纹的申请人: 和未满 12 周岁的儿童: 一张两寸照片。照片须符合如下要求: - 照片须显示整个脸部, 拍摄时应两眼平视面对前方的照相机; - 彩色照片, 背景为淡色; - 照片须为六个月内的近照, 且须符合本人实际面貌; - 照片须为免冠, 有特别宗教原因者除外。			
3.	A passport or other travel document, including two copies, one copy of all previous Schengen visa and entry & exit pages on both current and old passport. The passport should be valid for at least three months after the departure from Schengen area. Only passports which have been signed by the holders of the passports and that have at least two blank pages are accepted. For non-Chinese applicants a valid Chinese residence permit must be provided as well. 护照或其他旅行证件, 并附护照的身份页复印件两张, 并提供所有申根签证页以及出入境盖章页(包括旧护照)复印件。护照须在离开申根区后三个月仍然有效。护照需由持有人签名, 并且至少有 2 页空白页, 否则将被拒绝受理。非中国申请人还需提供有效的中国居住证。			
4.	If a new passport has been issued within the last year you should show the old passport and submit a photocopy of the identity page and all pages with stamps and visas. 如果在过去一年内签发的新护照, 您应该出示旧护照, 并提交该旧护照身份页及所有带公章和签证的各页复印件一份			
5.	Chinese Identity Card with one photocopy thereof (both sides, no translation). 中国身份证原件及其正反面的复印件。(无需翻译)			
6.	Original hukou and photocopy of all pages (no translation needed). 户口本原件及其所有页的复印件。(无需翻译)			
7.	Medical insurance valid for all Schengen states and covering any expenses which might arise in connection with repatriation for medical reasons, urgency medical attention and/or emergency hospital treatment or death during the stay (no original needed). The minimum coverage must be 30 000 EUR. It must cover the entire duration of stay in the Schengen area (until 24:00 local European time on departure date, please note that if the coverage period of insurance is stated in Beijing time you need to purchase one extra day of insurance after exit from Schengen area because of the time difference between China and the Schengen area.). Only printed insurance certificates will be accepted, not hand-written. The insurance must cover 100% of the costs. When applying for a multiple entry visa, the travel insurance must be valid for the first trip and applicant needs to have Travel Medical Insurance for any subsequent visits to the territory of Member States. Please note! You might need to present the original insurance or printed copy of electronic insurance to the border guards when entering the Schengen area! You can otherwise risk being denied entrance. 一份有效的旅行医疗保险, 保险需覆盖所有申根国家, 并且能够涵盖由于医疗或紧急医疗原因/紧急住院治疗而导致的遣返费用。(无需原件)最低保额为 30000 欧元。保险需涵盖整个申根国家停留期间(直到离开申根国家的欧洲当地时间 24: 00, 请注意, 如果保险时间写的是北京时间, 因为时差的问题您需要在离开申根地区日期后多买一天保险。)保单必须为打印文本, 不接受手写保单)。保险需要覆盖 100%的医疗费用。当申请多次往返签证时, 旅行医疗保险需从第一次旅行及后续申根国家的旅行都有效。请注意: 于申根国入境时, 应随身携带该保单的原件或电子保单打印件, 以备边防检查。如不携带, 将有可能被拒绝入境			

8.	As proof of relationship with referent for family visits, we require a Notary Certificate legalised by MFA. 如果申请探亲签证, 需提供邀请人和申请人的家庭亲属关系公证书, 该公证需经外交部认证。			
9.	As proof of relationship for visiting a friend, the friendship should be substantiated with original documents, original pictures, letter of invitation etc. 如果申请访友签证, 需提供邀请人和申请人朋友关系的原件材料, 如照片, 信件, 邀请或其他相关材料。			
10.	As proof of solvency of the applicant we require bank statements from the last 3 months, no deposits. In addition to this we also require: 经济担保-申请人过去 3 个月的银行记录单, 无需存款证明, 除此外还需要以下证明:			
	For employees: 申请人现如有工作: A letter from the employer (in English or Chinese with English translation) on official company paper with date signature and stamp clearly mentioning: -address, telephone and fax numbers of the employing company, -the name and position in the employing company of the signing officer -name, position, salary and years of service of the applicant -approval for leave or absence 请提供公司/单位出示的证明信原件(英文或中文附英文翻译件)。证明信须用正式公函纸书写, 相关领导签字, 写明日期并加盖公章。内容须包含: -申请人工作单位的详细地址, 电话及传真号 -证明信签字人的姓名, 职务 -申请人姓名, 职务, 薪资及工作年限 -准假证明			
	-A sealed copy of the business licence/organization code certificate of the employing company. -工作单位营业执照 / 组织机构代码证复印件, 并加盖公章。			
	For retired persons: 退休人员: -Pension certificate, with a copy thereof, OR the original letter of retirement from the employer, the letter should be printed on company letter head, signed and stamped. -退休证原件及其复印件或单位开具的退休证明信原件, 证明信需由单位抬头纸开具, 相关领导签字并盖单位公章。			
	-Proof of regular income -固定收入证明			
	For unemployed adults: 无业人员: If married: Letter of employment and income of the spouse. Notary Certificate of marriage, legalised by MFA. 若已婚提供配偶的工作证明和经济收入证明, 结婚公证书并经当地外事部门认证。			
	If single/divorced/widow/widower: Any other proof of regular income. 若单身/离异/丧偶: 其他正常收入证明。			
	If the applicant is covering his/her own expenses: the balance of the bank statement should cover at least SEK 450 per day in Sweden. 如果申请人自行承担在瑞典的费用, 需提供过去 3 个月的银行记录单, 在瑞典停留所需提供的最低资金为每天 450 瑞典克朗。			
	If the referent is economic guarantor and lives in Sweden, we require a proof of regular income over the last 3months (bank statement/salary receipts). The required amount is SEK 450/day in Sweden. 如邀请人身在瑞典并作为经济担保人, 需提供过去 3 个月内的固定收入证明(银行帐单/工资单)。所需金额为每天 450 瑞典克朗。			
	If the referent is economic guarantor and lives in China but invites the applicant to travel together to Sweden, we require: 如邀请人居住在中国并邀请申请人一同赴瑞典旅行, 需提供: -A copy of the referent's residence permit in China -邀请人在中国的居住证复印件			
	-Proof of regular income over the last 3 months e.g. bank statement / salary receipts -邀请人过去 3 个月的固定收入证明, 如邀请人的银行帐单或工资单			
	-Signed guarantee letter, i.e. if you pay for the applicants travel costs and stay in the Schengen area -邀请人签字的证明信, 如: 如果你承担申请人的在申根区的旅行费用和住宿费用			
	-Proof of a residence in the country of destination (address of where the applicant will stay), or invitation to stay with close family -申请人在申根国停留期间的住宿证明(申请人住宿的地址), 或申请人居住家庭的邀请函			
11.	A completed Invitation form to be filled in by the person inviting you, not older than 6months. 一份填写详尽的邀请表, 有效期六个月内, 由瑞典方邀请人填写			

12.	Civic registration/family certificate (personbevis/familjebevis) not more than 3 months old from the inviting person. 瑞典方邀请人的身份证明或家庭证明即 personbevis/familjebevis, 需为近 3 个月内开具的。			
	A photocopy of the passport information page of the inviter and a valid visa page or residence permit from the person inviting you. 瑞典方邀请人的护照首页及瑞典签证 或 居留卡的复印件一份。			
13.	For students: 学生: -student card, with a copy thereof, -学生证原件和复印件			
	-Original letter from the school/institution with full address, telephone number of the school/institution, permission for absence for the applicant and name and function of the person giving the permission. The letter should be printed on school/institution letter head, stamped and signed. -学校证明信原件。证明需由学校/学院抬头纸开具, 包含学校详细地址, 电话, 缺勤许可, 校/院/系领导的签字并盖校/院/系公章。			
14.	For minors (under 18 years): 如申请人未满 18 岁, 需提供: Please note that the application form for minors should be signed by a person exercising permanent or temporary parental authority or legal guardianship. - 请注意, 未满 18 周岁申请人的申请表需由父母双方或其法定监护人签字			
	-Notary Certificate of family relation or proof of guardianship legalised by MFA. -该家庭成员关系或监护关系的公证书, 该公证需经外交部认证。			
	- Custodians' ID cards with photocopies of both sides (no translation needed). - 监护人的身份证原件及其正反面复印件。(无需翻译)			
	If the minor is travelling alone or with only one parent, we also require: 如果申请人未成年并单独或与父母双方中的一位共同旅行, 需提供: - Notary Certificate of permission to travel from both parents, or legal guardians (when the minor is travelling alone) or the parent or legal guardian not travelling (if minor is travelling with one parent), legalised by MFA and when not in China, attested by the relevant authorities in the country of residence. If there is only one custodian, a notarized and legalized document showing that this is the case must be attached to the application. - 父母双方或法定监护人同意旅行的公证书(如果未成年人单独出行), 未出行父母一方或者法定监护人同意旅行的公证书(如未成年人与父母一方出行)。该公证需经外交部认证, 如果父母不在中国, 请在居住国家办理相关材料。如果只有一位监护人的情况下, 必须说明情况, 并有有效的公证和认证。			

General requirements:

Apart from the exceptions mentioned in the checklist, the required documents need to be submitted in original and an authorized translation must be attached to any documents in Chinese.

2. The applicant has submitted the supporting documents above. I have advised him/her that failure to submit all necessary documents may result in the application being refused, but s/he has chosen to proceed with the application.

3. The applicant is aware that the processing time, even for complete applications, can be up to 15 calendar days from the day that the application has been received at the Embassy/Consulate. However, s/he has chosen to voluntarily undertake the consequences if failed to submit the application at least 15 calendar days before the intended departure.
