

Checklist for family and friends visit application - Sweden

1.	Application form filled in completely and signed by each applicant			
	One recent passport size colour photograph.			
2.	The photo must be: full face (facing the camera directly with your eyes looking straight at the camera); in colour with a light background; no more than six months old and resemble you; you must be uncovered, unless religious reasons.			
3.	Original passport must be submitted and duly signed in front of competent authorities. The passport must be valid for at least 90 days from the expiry date of the entry visa. The validity of the passport must not exceed 10 years. Two copies of the bio page and copies of all previous Schengen visas.			
4.	Valid UAE residence visa, valid for 3 months beyond the intendeddate of departure from the territory of the Member States			
5.	Copy of travel arrangements and booked return (flight details)			
6.	Bank statement copies for the last 3 months			
	Confirmation letter in original (English) from the employer, stating salary, applicant's current employment details and date of joining the company.			
7.	The letter should also specify the dates of approved leave and state the purpose of visit.			
	The letter should be printed on the company's letterhead and signed by the authorized signatory, and mention the name and position of the signatory			
8.	If the applicant is the owner of the company, copy of the trade license			
9.	Hotel reservation / accomodation proof is requested for applicants who will not be living with the reference			
10.	Invitation letter from the reference in Sweden mentioning all details such as accomodation with address and contact number or Completed Appendix E/ Inbjudan			
11.	Copy of reference's passport and residence permit and Extract of the Population Register in Sweden (Personbevis)			
12.	All applicants must provide proof of travel insurance & medical insurance valid for the trip, valid for all Schengen countries and having a coverage amounting to EUR 30,000/-
