0	Issued within the last 10 years and with at least 3 months validity after the scheduled return, with at least two blank pages. Handwritten passports and passports with observations regarding the front page (bio data) cannot be accepted.

0	White background, not older than 6 months (size 35 – 40 mm in width, not copied or scanned picture).	
0	3 pictures pasted on the three application forms. The 4 th picture has to be clipped on the last page of the passport.
