Please submit 3 application forms and 2 sets of the required documents as specified:  $\boxtimes$ Please submit the documents in the exact order given below, please do not staple any document. Valid national passport: Issued within the last 10 years and with at least 3 months validity after the scheduled return, with at least two blank pages. Handwritten passports and passports with observations regarding the front page (bio data) cannot be accepted. 4 passport size pictures:  $\Box$ White background, not older than 6 months (size 35 – 40 mm in width, not copied or scanned picture). 3 pictures pasted on the three application forms. The 4th picture has to be clipped on the last page of the passport. Stapled or pinned pictures cannot be accepted. Previous passport/s: If any, bound together with rubber band, not stapled. Introduction letter from the employer: 2 x (1 original + 1 copy) covering letter on a business letterhead from the employer / company mentioning your position, duration of your service, the dates and purpose of the trip and if your expenses are being covered by the employer. Invitation letter from the business partner in Switzerland: 2 x (1 original + 1 copy) With full details of the inviter: full name, address, Email-ID and telephone number. Mentioning the invitee details, the dates and purpose of the trip Travel Insurance: Please refer to the list of approved Indian travel insurances: https://www.eda.admin.ch/dam/countries/countries-content/india/en/visa/SchengetList-Travel Insurance Companies-EN.pdf Minimum coverage of 30,000 Euro / 50,000 USD / 50,000 CHF per person. Coverage of all expenses which might arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment. The insurance has to cover the entire stay in the Schengen territory. Applicants who wish to apply for a six months or one year multiple entry visa are not obliged to provide a 180 (365) days coverage. It is sufficient to submit an insurance policy covering the first journey. Flight reservation: with name. 2 copies of the proof of financial status: All documents have to be originals, in format A4, with stamp and signature of Bank. If employed: Proof of employment: employment contract & last 3 months salary slips & last 3 months salary bank account statements. Personal ITR (only ITR-V, Indian Income Tax Return Verification Form or Acknowledgement is accepted) for the last 2 assessment years. If self-employed and/or company owner: Business registration certificate / GST Registration with annex A & B /partnership deed / proof of proprietorship, or other proof of ownership. Last 3 months personal & business bank account statements. Company's & personal ITR (only ITR-V, Indian Income Tax Return Verification Form or Acknowledgement is
