^(*) Declaration of sponsorship: The Regional Consular Center in Bangkok may require the issuance of a declaration of sponsorship during the verification of a visa application if the applicant does not have sufficient financial means to support himself in Switzerland, or if the Regional Consular Center in Bangkok has reason to doubt sufficient financial funds exits. The declaration of sponsorship will be provided by the Regional Consular Center's own motion. It is not available online. By handing out a declaration of sponsorship the process can be delayed (slowed down) up to a minimum of 15 days.
