1	<b>Visa application form, original:</b>  Duly filled out, dated and signed by the applicant. <b>The visa application form must be signed by both parents in case of minor child.</b>  <b>It is mandatory that the mentioned data information on the Schengen visa application form such as addresses, phone numbers etc. has to be identical with the personal data of the applicant. Photocopy of the residence permit, if host is not a Swiss citizen.</p> <p><b>Applicant and host are not related (i.e. friendly or loving relationship):</b> In case of non-official relationship, one photocopy of the host's passport (first page with biometric data) with a copy of entry/exit stamps to Thailand. The relationship must be described comprehensively in the invitation letter and, if necessary, supplemented by further documents</p>			
11	<p><b>Employment and financial proof:</b></p> <p><i>If Employed:</i> - Work Certificate indicating the number of vacation days granted, the position in the company and the monthly salary</p> <p><i>If Student:</i> - Academic certificate such as an enrolment confirmation of the school or university, show original and submit photocopy.</p> <p><i>If Self Employed:</i> - Business registration stating the applicant's name</p> <p><b>To be provided by all applicants: Proof of sufficient funds</b> Bank Statement for the last three months, original with bank stamp; if the applicant is not in the position to provide proof of financial means, a declaration of sponsorship (*) will be handed out.</p>		X	
12	<p><b>Documents related to minor child:</b></p> <p>- Birth certificate, show original and submit photocopy</p> <p>- Parental consent for the minor child that is either travelling abroad alone or with only one parent: a) <i>An official parental consent for the planned travel abroad must be submitted, in case that one of the parents or both of them are not going to travel together with the minor child. This document must be issued by Amphoe. Show original and submit photocopy</i> b) <i>Or the declaration of consent letter signed by the parent/s who is/are not traveling with the minor child (sign at VFS Global Visa Center in person). Show original and submit photocopy.</i></p> <p>- If the parents are divorced, or - if the parents were not married at the time the child was born, a proof of child custody, issued by the Amphoe, must be submitted (copy).</p> <p><i>In case that one parent has passed away, a death certificate must be submitted.</i></p> <p><b>Signed authorization letter from the parents in case that both parents cannot appear in person during the submission of the visa application. Photocopies of the parents' passports (personal data page) must also be submitted.</b></p>		X	
13	<p><b>Foreign national residing in Thailand:</b></p> <p>- Original and copy of work permit (if applicable) - Re-entry stamp from Thai Immigration, valid after coming back from the Schengen states</p>		X	
00	<b>Documents in Thai language must be translated into English or into one of the Swiss national languages (G, F, I) by a translation office.</b>	X		"Translation Service"
00	<b>If submitting documents to prove family relationships from countries other than Thailand, legalization from competent Embassy or Consulate is required.</b>		X	

(\*) Declaration of sponsorship: The Regional Consular Center in Bangkok may require the issuance of a declaration of sponsorship during the verification of a visa application if the applicant does not have sufficient financial means to support himself in Switzerland, or if the Regional Consular Center in Bangkok has reason to doubt sufficient financial funds exists. The declaration of sponsorship will be provided by the Regional Consular Center's own motion. It is not available online. By handing out a declaration of sponsorship the process can be delayed (slowed down) up to a minimum of 15 days.
