| <ul style="list-style-type: none">● Application form duly completed and signed Fully completed in Portuguese or English and signed two times and dated by the applicant himself. It is mandatory to provide current UAE address, local contact number and email address in bold and clearly written. | | |
| <ul style="list-style-type: none">● One recent passport size photo Passport size with white background; must be recent (not older than 6 months). | | |
| <ul style="list-style-type: none">● Original passport and one passport copy with UAE Residence Permit The passport and residence visa must be valid a minimum of 3 months after your intended departure from the territory of the Member States, signed by the bearer, shall contain at least two blank pages (face to face) and should not be issued more than 10 years ago. | | |
| <ul style="list-style-type: none">● Valid travel insurance (Original and stamped) Covering the entire territory of all Schengen Member States with a minimum coverage of 30.000,00 € (euros) for medical expenses. The insurance policy must cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. An original certificate policy clearance is mandatory. | | |
| <ul style="list-style-type: none">● Proof of accommodation Proof of accommodation with full address (name, street, city, zip code, contact information) during intended stay: hotel reservation, rental contract or proof of residential property. | | |
| <ul style="list-style-type: none">● Work Contract/Work Promise Declaration issued by the Employment and Training Institute (IEFP) | | |
| <ul style="list-style-type: none">● Non-Criminal Record Certificate/Professional Certificate Criminal record certificate from the country of origin or the country where the applicant is residing for over a year. Request for criminal record enquiry by the Immigration and Border Services (SEF) Professional certificate, when such profession is regulated in Portugal. | | |
| Migrants Entrepreneurs: Investment operations executed; Proof of financial means available in Portugal , including those obtain through a financial institution is Portugal, and proof, by any means, of intention to invest in Portuguese territory; or, Start-up Visas -Declaration issued by the Agency for Competition and Innovation (IAPMEI) , certifying the signing of an incubation contract with a certified incubator, in accordance with Article 6o of Normative Order n.º 4/2018 of the Minister of Economy, of 2 February that regulates the «Startup Visa» Program | | |
| <ul style="list-style-type: none">● Proof of means of subsistence (if applicable) Proof of means of subsistence can be produced through a statement of responsibility issued by the workers hosting entity. To determine means of subsistence, means obtained through a work contract or work contract promise should be taken into consideration | | |

NOTE: Original documents must be submitted; additional photocopies may be required.

- Failure to submit all the necessary documents may lead to the rejection of the visa application.
- The Consular Post reserves the right to request documents other than those mentioned above whenever it deems convenient.
- Even if all the documents necessary for the process are presented, it doesn't imply the automatic granting of the visa. Refusal of the visa application shall not entitle to reimbursement of the visa fee.

The Embassy of Portugal in Abu Dhabi reserves the right to request additional documents if deemed necessary, may call the applicant for an interview.
