1	<b>Application form duly completed and signed</b> <ul style="list-style-type: none"><li>Fully completed in Portuguese or English and signed and dated by the applicant</li></ul>		
2	<b>One recent passport size photograph</b> Requirements: <ul style="list-style-type: none"><li>should not be older than 6 months + in colour with white background + 3,5 by 4,5 cm</li></ul>		
3	<b>Passport / travel document</b> Must: <ul style="list-style-type: none"><li>have a validity of at least 3 months after the intended stay</li><li>be issued within the previous 10 years</li><li>have 2 blank pages</li><li>it is recommended to attach previous passports (if applicable)</li></ul>		
4	<b>Non Iranian Nationals residing in Iran</b> <ul style="list-style-type: none"><li>Iranian Resident Permit valid for at least 3 months after expiry of the requested visa</li></ul>		
5	<b>Flight reservations</b>		
6	<b>Confirmed accommodation for the entire stay</b> <ul style="list-style-type: none"><li>A hotel reservation, or alternative proof of accommodation for the entire stay</li></ul>		
7	<b>Travel medical insurance</b> Must: <ul style="list-style-type: none"><li>cover the entire territory of all Schengen Member States with a minimum coverage of 30.000,00 € (euros) for medical expenses</li><li>cover expenses that might arise in connection with repatriation for medical reasons, urgent medical attention, emergency hospital treatment or death during stay. A certificate policy is mandatory</li></ul>		
8	<b>Officials (*)</b> <ul style="list-style-type: none"><li>act of appointment or certificate of tenure and last payslip</li></ul>		
9	<b>Verbal note or mission order</b> Must have: <ul style="list-style-type: none"><li>given name(s) and last name(s) of the missionary; official job title; purpose of the trip; date of employment; commitment of the sending entity to cover trip costs for the missionary</li></ul>		
10	<b>Invitation of the inviting body in Portugal</b>		
11	<b>Bank account statement for the last 3 months</b> <ul style="list-style-type: none"><li>Has to show financial transactions/circulation of the money in the account for the last 3 months</li></ul>		
12	<b>Proof of ownership of property in Iran (if applicable) (*)</b>		
13	<b>Official translation of birth certificate (Shenasnameh) (*)</b>		
14	<b>Copy of the passport and previous visas</b>		

**PLEASE NOTE: Pointers (\*) all the documents presented must be officially translated to Portuguese or English language and attested by both Ministry of Justice and Ministry of Foreign Affairs.**

The Embassy of Portugal in Tehran reserves the right to request further documentation if deemed necessary, may call the applicant for an interview. False or falsified documents, including fake bookings, will lead to the refusal of visa and/or further consequences.
